In other good news this year, we were awarded a matching grant from the National Wilderness Stewardship Alliance. Also, great news, the Hite's Cove Trail has at long last been officially reopened. So many of you have worked on this as a labor of love and can be proud it is open to the public once again. Probably the best wild flower hike in Mariposa County, gateway to the South Fork Trail and closed since the 2018 Ferguson Fire, Mariposa Trails volunteers have worked tirelessly to restore this historic trail.

Year in Review

Trails

In 2020, Mariposa Trails completed 31 trail-tending outings, including 2 overnight trips, on 9 different trails with 39 volunteers resulting in 1,279 volunteer hours equating to a labor value of \$32,524 (1,279 @ \$25.43 per hour). Over 10 miles of trail were cleared, over 189 logs cut from trails; and 6 major trail gully crossings repaired.



2020 Accomplishments

Skelton Creek Trail cleared of 16 logs off the trail/1-mile of trail cleared/0.1-mile of new tread installed.

Virginia Creek Trail cleared of 75 logs off the trail/1.5-miles of trail cleared

Alder/Willard Creek Trail cleared of 5 logs off the trail/1-mile of trail cleared

North Fork Merced Trail cleared of 3 logs off the trail/0.5-mile of trail cleared

Owl Creek Area Trails cleared of 6 logs off the trail/2-mile of trail cleared/0.6-mile of erosion control applied.

Jerseydale 2020 Project

United States Forest Service lands near Jerseydale are the most proximate public lands to the population centers of Mariposa. They also contain roads and trails used by a variety of users, including hikers, trail-runners, mountain bikers, equestrians and OHV's. A total of 816 volunteer hours were dedicated to the improvement of trails in this area, and include:

- Macready Trail
- Upper Skelton Creek
- Manzanita Loop Trail
- Heliport Service Road
- Virginia Creek Trail











Highland Trails

Temperatures in the South Fork Canyon can be extreme in the summertime. Fortunately, there are 2 trails of note that provide respite and spectacular views from the highlands of the South Fork. 4 outings (2 of these overnight trips) were dedicated to scouting and clearing portions of the trails, and include:

- The Granite Creek Saddle Trail
- The Pinoche Ridge Trail







The South Fork Trail

The 21-mile long "South Fork Trail" is a key link in a regional trail system that connects the foothills in Mariposa County with Yosemite National Park. It spans an elevation of 4,000 feet, traversing through some of the wildest and culturally rich landscapes in the Sierra Nevada Mountains. In 2018, portions of the trail were closed due to fire and floods.

HITE'S COVE TRAIL

In 2020, 310 volunteer hours were dedicated to completing the initial restoration efforts of the Hite's Cove Trail, which enabled the trail to be opened in November 2020, having been closed since July 2018.





ALDER/WILLARD CREEK TRAIL

In 2020, 100 volunteer hours were dedicated to repairs. Unlike the Hite's Cove Trail, which is more popular and more easily accessed, this trail is in great need of repairs, and will be a focus of work in 2021.
